The Issuer is a mineral exploration company, incorporate under the laws of the Province of British Columbia, Canada, and its principal activity is the acquisition and exploration of mineral properties. During the month of November 2022, the Issuer continued with general and corporate operations.

November 10, 2022

The Issuer announced that it has concluded a soil sampling campaign at its lithium prospective Mistumis project in the James Bay Region, Quebec. 1,918 soil samples have been delivered for analysis to Activation Laboratories Ltd. in Ancaster, Ontario. Samples will be analysed using ICP-OES+ICP- MS (ppm) method. Results of the analysis are expected in approximately 6 weeks.

November 22, 2022

The Issuer announced an airborne geophysical survey has been completed over its Mistumis and Route 381 lithium exploration projects in the James Bay region, Quebec. Megawatt engaged Prospectair Geosurveys Inc. of Gatineau, Quebec to perform a high resolution Heliborne Magnetic and Spectrometric survey over the properties flying a total of 2,819-line kilometres. The survey was carried out with traverse lines oriented N000 in order to properly map the dominant magnetic/geological strike, and with a 50m line spacing. Control lines were flown perpendicular to traverse lines and at a 500 m line spacing. Following receipt of the final airborne geophysical survey results and associated data evaluation, the Issuer is planning to begin a diamond drilling program.
