During the month, the issuer continued to work on developing and commercializing the intellectual property of CERVAI™, a brain health and

wellness AI solution that estimates brain age and provides a brain health score.

On April 3rd, 2024, the Issuer announced it has added Drexel University as a new test launch site of BRAIN AGE®, a world-first consumer brain health and wellness AI solution.

On April 23rd, 2024, the Issuer announced that BRAIN AGE® Brain Health AI, a world-first consumer brain health and wellness AI solution that estimates brain age and provides a brain health score, is available to Canadian-based clinics focusing on health and wellness, sports and physical therapy, mental health, chiropractic care, or clinical and academic research for neurological and cognitive disorders.

On April 25th, 2024, announced a clinical validation milestone of the BRAIN AGE® Brain Health AI Platform (“BRAIN AGE®”), a world-first consumer brain health and wellness AI solution that estimates brain age and provides a brain health score, with a first-of-a-kind peer-reviewed paper in Frontiers in Neuroergonomics, titled “Brain-age estimation with a low-cost EEG-headset: effectiveness and implications for largescale screening and brain optimization.
